Review/Approval

Grow Detroit's Young Talent Service Provider Funding Recommendations

The committee discussed the Audit and Finance Committee's role in reviewing the three (3) Grow Detroit's Young Talent service provider funding recommendations in light of DESC's procurement policy as well as the DESC Board By-laws. The specific funding recommendations for consideration by the committee were: (1) Summer Youth Coordinator; (2) "Hub and Spoke Model" Service Agencies; and (3) "Hub and Spoke Model" Community-Based Development Organization. Further conversation ensued regarding the agency's procurement process and methodology. The committee also discussed potential changes to DESC's procurement approval process going forward.

The committee initiated a review of the funding recommendations as presented by DESC staff. Director Laura Hughes noted that the funding recommendations as packaged did not include a sufficient amount of information for this committee to properly consider them. She requested that DESC's staff present the total budget for summer youth employment and how the funding recommendations align with that specific information.

A motion was made by Member Trulik to ask the DESC Board to review the GDYT funding recommendations, supported by Director Hughes. Motion Carried Unanimously.
