111.	Finance Report	 Mr. Uhl opened the meeting and called upon Terri Weems, DESC President to present the proposed budget for Fiscal Year 2022 / 2023. Terri Weems introduced Traci Sassak, the new Chief Financial Officer of Detroit Employment Solutions Corporation. Traci Sassak gave a brief overview of her previous position as a CFO at another Michigan Works organization. Terri Weems: 	Ric Preuss asked that he be given a list of the training that the Learn to Earn program will be supporting. Paul Trulik asked that in a future meeting there be a slide or information regarding the impact



		 Detailed the proposed budget and insight into the budget development process. Provided information regarding rules DESC is required to follow as recipients of WIOA and Wagner Peyser funding, amongst other funding sources. She also detailed the signature programs we support, including GDYT, Learn to Earn, Get Paid to Learn a Trade, Skills for Life, Returning Citizens Support, Business Start Up Support, and other programming. Shared that the bulk of the increases in the budget related to ARPA, and that there is approximately \$30 million of funding included that has already been awarded. Discussed that DESC has applied for additional ARPA funding that may increase the total budget and that due to our conservative budget philosophy, we will not add them until we've been approved for them. Advised that the budget allows for increased hiring to support the increased programming commitments being made in FY 2023. Committee discussion ensued.
