He then took a few moments to review the site and allowed time for questions.

### IMPACT OF DIASBILITIES ON YOUTH CRIME

Ms. Annie Ellington, Director, Detroit Youth Violence Prevention Initiative, thanked the Council for inviting her and shared data about youth violence and the impact of that data on the community. She believes that there is a lot of work that needs to be done in order to ensure that youth in the city feel safe, particularly when they travel to and from school. Detroit youth are exposed to significant amounts of violence and if the issue of violence is not addressed, youth can suffer from mental health issues. She also discussed the physically disabling factors that stem from violence.

Member Verna Brocks shared information about a town hall meeting held by the National PTA and the Detroit Council PTA regarding Serving Families of Children with Special Needs which took place on Monday, December 2, 2013 at the Charles H. Wright Museum of African American History.
